Furthermore, the attendee must also be a registered Individual member of The Judo Association of Hong Kong, China. Any authorized representative must present a confirmed Letter of Authorization bearing an official chop and signature from the respective member club in order to attend the AGM. The Letter of Authorization must be received by the Secretariat of the Association no less than 48 hours in advance, so as to allow time for the confirmation procedures to be completed.
